#### PRE-PAID GOLF PACKAGE - OFFERING I

#### **SUMMARY**

The pricing below may not reflect any discretionary pre-season discount offerings granted by RotaryLinks.

RotaryLinks is a public golf facility located on 3000 Snow Eagle Drive in Fort McMurray. RotaryLinks is incorporated under the laws of Alberta, for the purposes of developing, managing and operating a Public Golf Facility.

The Rotary Club of Fort McMurray has granted RotaryLinks the sole and exclusive right to use, manage, further improve, operate and maintain the Golf Course and to market and sell to the general public a limited number of Pre-Paid Golf Packages for the use thereof.

RotaryLinks is now offering for sale a limited number of Seasonal Golf Memberships. The Seasonal Golf Membership will entitle the purchaser of such Seasonal Membership (referred to

herein as the “Purchaser”) to use the Golf Course facilities for the 2022 season. The Seasonal Membership will be redeemable at the start of the 2021 golf season and will terminate at the end of the golf season in 2022.

RotaryLinks may sell additional Seasonal Membership or may sell “Life-Time Memberships” and may by this and subsequent offerings, sell such type and number of Seasonal Memberships or “Life Time Memberships” as it deems desirable or necessary to meet its capital and operating requirements.

All Purchasers will be entitled to the use of the Golf Courses and related facilities during the term of their Seasonal Membership. Seasonal Membership will survive the death of the Purchaser and will be honored by the RotaryLinks in the hands of the Purchaser’s lawful beneficiary, expiring at the end of the 2022 golf year.

## ROTARYLINKS

### **2022 Seasonal Membership - Adult**

For a price of One Thousand Six Hundred and Forty-Five Dollars (\$1,645.00) plus GST, the purchaser would be granted in the 2022 season, playing privileges 7 days a week. This package **does NOT** include the cost of a rented power cart. Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks. Purchasers may also establish a charge account with RotaryLinks to be used within the facility, which requires a valid credit card account to be provided.

### **2022 Seasonal Membership – Couple**

For a price of Two Thousand Eight Hundred and Five Dollars (\$2,805.00) plus GST, a legal couple either by marriage or common law would be granted in the 2022 season, playing privileges 7 days a week. This package **does NOT** include the cost of a rented power cart seat but may be added for an additional cost as determined by RotaryLinks for the 2022 golf year. Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks. Purchasers may also establish a charge account with RotaryLinks to be used within the facility, which requires a valid credit card account to be provided.

### **2022 Seasonal Membership - Senior**

For a price of Nine Hundred Ninety Dollars (\$990.00) plus GST, the purchaser who is 50 years or older on May 1st, 2022 would be granted in the 2022 season, playing privileges 7 days a

week. This package **does NOT** include the cost of a rented power cart seat but may be added for an additional cost as determined by RotaryLinks for the 2022 golf year. Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks. Purchasers may also establish a charge account with RotaryLinks to be used within the facility, which requires a valid credit card account to be provided.

### **2022 Seasonal Membership - Student**

For a price of Seven Hundred and Seventy-Five Dollars (\$775.00) plus GST, the purchaser who is enrolled in post-secondary studies at a recognized institution in on April 1, 2022 would be granted in the 2022 season, playing privileges 7 days a week. This package **does NOT** include the cost of a rented power cart seat but may be added for an additional cost as determined by RotaryLinks for the 2022 golf year. Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks. Purchasers may also establish a charge account with RotaryLinks to be used within the facility, which requires a valid credit card account to be provided.

. Individuals may be required to provide proof of enrollment at time of membership processing.

### **2022 Seasonal Membership – Junior**

For a price of Two Hundred Twenty Dollars (\$220.00) plus GST, the purchaser who is under 18 years of age on May 1, 2022 would be granted in the 2022 season, playing privileges 7 days a week. This package **does NOT** include the cost of a rented power cart seat but may be added for an additional cost as determined by RotaryLinks for the 2022 golf year. Provided the individual has a valid driver's license with no restrictions. Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks.

### **2022 Seasonal Membership – Family**

For a price of Three Thousand and Twenty-Five Dollars (\$3,025.00) plus GST, the purchaser, their legal spouse and up to three legal dependents would be granted in the 2020 season, playing privileges 7 days a week. This package **does NOT** include the cost of a rented power cart seat but may be added for an additional cost as determined by RotaryLinks for the 2022 golf year. Power cart seat membership may not be shared and are purchased on an individual basis. *Please note: Junior Members would not be required to purchase a seat in a power cart if they are riding.* Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks.

Purchasers may also establish a charge account with RotaryLinks to be used within the facility, which requires a valid credit card account to be provided.

### **2022 Seasonal Membership - Weekday**

For a price of One Thousand Three Hundred and Thirty-Five Dollars (\$1,335.00) plus GST, the purchaser would be granted in the 2020 season, playing privileges 5 days a week (Mon-Fri). This package **does NOT** include the cost of a rented power cart seat but may be added for an additional cost as determined by RotaryLinks for the 2022 golf year. Purchasers shall reserve the right to book tee times 7 days in advance and shall receive additional discounts on select merchandise at the facility at the discretion of RotaryLinks. Purchasers may also establish a charge account with RotaryLinks to be used within the facility, which requires a valid credit card account to be provided.

### **Payment Terms – Seasonal Membership**

To qualify for early bird discount of 10% off the regular rate all payments for seasonal membership shall be processed as a one-time fee. No payment installments shall be granted to the purchaser unless special circumstances are granted by RotaryLinks upon written agreement.

If an individual chooses to have his or her membership dues processed on a monthly basis no early bird discount will apply. Payment for full cost of membership dues would be made in four (4) equal payments with the first payment processed at time of application with remaining three (3) payments in thirty (30) day installments. A processing fee of 3% will be applied to the total cost of the membership in this case.

### **Public Play**

The Golf Facility will be open to the public on a green fee basis and, except for the rights of Purchasers to play without the payment of green fees, the public shall be entitled to all privileges of the Purchasers, including the right to use and enjoy the Clubhouse and all other facilities associated with RotaryLinks.

### **Seasonal Membership Limitations**

RotaryLinks reserves the right to limit the number of Seasonal Membership held by any one individual or corporation. The Seasonal Membership offered do not extend to the Purchasers any right, license or privilege other than the ability to play golf on the Golf Facility. The

management and operation of the Golf Facility shall remain in the absolute discretion of the RotaryLinks and Purchasers shall not be given any rights with respect to the constitution of RotaryLinks or the appointment of its Directors or Officers. Purchasers are not entitled to any share of the revenues that may be generated from the operation of the Golf Facility, Clubhouse or other related entities and Seasonal Memberships do not grant Purchasers any interest in the ownership of RotaryLinks.

RotaryLinks also reserves the right to limit the use of the facility as it sees fit to ensure the facility does not receive any unnecessary damage that may be caused due to playing conditions.

Seasonal Memberships shall not be used for public re-sale. Should it be determined that a Purchaser is allowing or has allowed his or her Seasonal Membership to be used for the purposes of public green fee re-sale the result will be the automatic termination and redemption of the Seasonal Membership. The redemption of the Seasonal Membership will be less the full value of all the golf sold by the Purchaser for golf re-sale. There shall be “ZERO” tolerance in this regard by RotaryLinks.

Seasonal Membership are only valid for the year that they are issued or as otherwise indicated in the term and conditions.

## ROTARYLINKS

### **Location and Access**

RotaryLinks (the “Golf Facility”) is located on approximately 71 hectares of land within the City of Fort McMurray, Alberta at 3000 Snow Eagle Drive. The Golf Facility is readily accessible to everyone and subject to weather and conditions will be open for general play between the months of April/May (weather permitting) and October.

### **Golf Facility Description**

RotaryLinks is an 18-hole public golf facility. This Les Furber designed facility will feature an 18-hole Championship course and driving range. A wide variety of tees on each hole allow for both challenge and enjoyment of the courses.

## **SEASONAL MEMBERSHIP**

### **General**

Persons who apply for Seasonal Membership for the use of RotaryLinks and whose applications are accepted and paid for in full (“Purchasers”), will be entitled to playing privileges at the Golf Facility, the nature and extent of which are specified within.

### **Transferability of Seasonal Membership Golf Packages**

Seasonal Memberships will survive the death of the Purchaser and will be honored by RotaryLinks in the hands of the Purchaser’s lawful beneficiary once that person has fully satisfied the Committee that he or she is unquestionably the lawful beneficiary.

### **Redemption of Seasonal Membership**

RotaryLinks might agree to redeem from a Purchaser his or her Seasonal Membership. On receipt of a written notice from a Purchaser that the Purchaser wishes RotaryLinks to redeem the Seasonal Membership, RotaryLinks shall, if it decides to redeem the Seasonal Membership, pay an amount to be determined by dividing the Seasonal Membership fee by the number of days remaining in the Seasonal Membership and multiplying the result by the number of full days then remaining in the Seasonal Membership.
